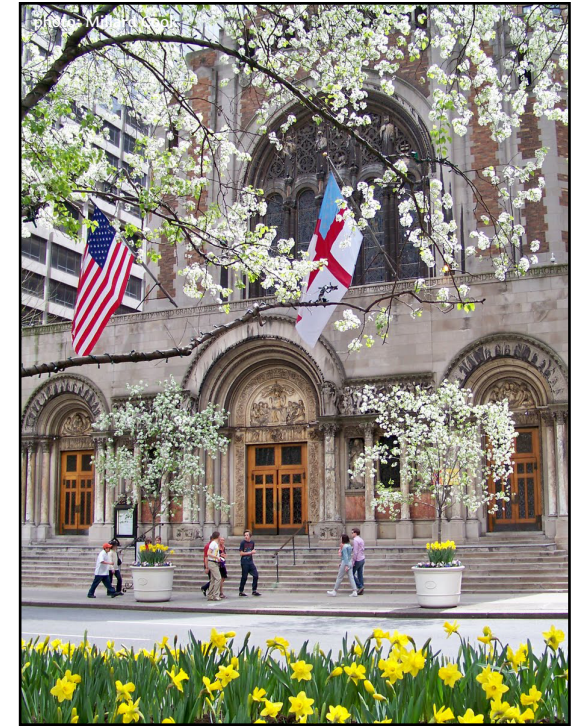


# ST BART'S WAYS TO GIVE

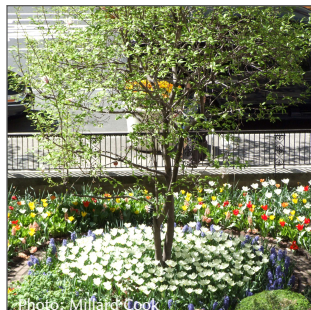

### THE STEWARDSHIP CAMPAIGN

#### What is the Stewardship Campaign and what does it support?

The Stewardship Campaign provides the unrestricted annual operating support that enables St. Bart's to keep our doors open to all. In addition to powerfully beautiful liturgy and music, we offer comprehensive services to those in need, creative and educational programs for youth and families, and a lively forum for the arts, culture and social interaction.

#### What is the goal of the Stewardship Campaign?

The goal of the current Stewardship Campaign is \$2.86 million. We ask all to participate by giving in proportion to what you have been given, in whatever way you are most comfortable, and to pledge early so that St. Bart's may responsibly plan the budget for the following year.

### GIVING TO THE CAMPAIGN

#### First, You Pledge!

A stewardship pledge states your intention to support the work of St. Bart's throughout the year. Giving proportionately means offering a percentage of your income as you are able. These pledges help us sustain our operating budget.

#### Honoring Your Pledge: How to Pay

Pledges or contributions can be paid as a single gift or in installments: weekly, monthly, or annually. Your pledge can be in the form of cash, check, credit card, or transfer of stock. Payments can be made securely online, by mail, in the offering plate during services, or by contacting the Office of Stewardship and Development.

#### *Do I have to be a member of St. Bart's to make a contribution?*

No, philanthropic contributions are always welcome from friends of St. Bart's.

Gifts may be made to the distinct 501(c)(3) nonprofit enterprises: Mid-Manhattan Performing Arts Foundation (and Friends of Great Music), the St. Bartholomew's Conservancy (restoration projects of our landmark building), Crossroads Community Services (food and shelter programs), and the St. Bartholomew Community Preschool Foundation.

### ST. BARTHOLOMEW'S CONSERVANCY

In appreciation of the philanthropic support from our neighbors in the business community, the Friends of the Conservancy program offers special benefits for business leaders, corporate employees, and professional affiliates, with the goal of fostering a community spirit while supporting the restoration of our landmark buildings.
